## Statement of support to Central European University (CEU)

Dear Minister Balog,

I am writing to express my concern at proposed legislative changes to the status of Central European University (CEU) that would prevent CEU's continued operation in Hungary.

Running post-graduate programs social sciences and humanities, CEU has created a generation of leaders in international and domestic politics, science, businesses, and other societal institutions. CEU alumni have served as presidents, ministers, and other governmental officials in a few countries, taken posts as heads and officers of international and country-level NGOs including the UN system, shown break-through results in science, and taken flagship actions in leading the world against environmental disasters. Therefore, the closure of CEU would be a big loss for Hungary and the European Union, if not for the world. As a scientist focusing on sustainable energy development and climate change mitigation, I observe what a huge difference have CEU, its staff and alumni made in my field, and this is why I call the Hungarian government to revise the legislation that may prevent CEU to deliver this excellence.
